Issue of Options

White Rock Minerals Ltd ('White Rock') wishes to advise today that a total of 1 million unquoted options to subscribe for White Rock shares have been issued to a technical consultant engaged in the execution and management of the Company's intended copper exploration drilling program on the Mt Carrington project in northern NSW.

The options will be issued subject to the following exercise prices and expiry periods:

- 500,000 options, vesting on 1 July 2015, at an exercise price of \$0.040, expiring 30 March 2018
- 500,000 options, vesting on 1 October 2015, at an exercise price of \$0.045, expiring 30 March 2019

The exercise prices for the above options represent respective 60%, and 80% premiums to the closing price of White Rock Shares on the ASX on 30 March 2015, being the last trading date before the date of issue.
