PLACEMENT & SECTION 708A(5) NOTICE

Bluechiip Limited ("**Bluechiip**" or the "**Company**") (ASX:BCT) advises that 20,411,212 new fully paid ordinary shares were issued today without disclosure to investors under Part 6D.2 of the Corporations Act as detailed in the accompanying Appendix 3B.

As previously announced, Messrs Iain Kirkwood and Michael Ohanessian have committed funds to the placement (\$81,500 in aggregate) but the issue of these shares will be subject to shareholder approval to be sought at the 2015 AGM.
