Issue of Shares

White Rock Minerals Ltd ('White Rock') refers to its ASX announcement dated 27 July 2015 and advises it has today issued 5,000,000 fully paid ordinary shares in a placement to PHD Investments Ltd at an issue price of 2 cents each to raise \$100,000.

White Rock also advises that a total of 2,102,121 fully paid ordinary shares were issued to Lion Capital Advisory Pty Ltd. Lion Capital is currently providing various corporate advisory services to White Rock under a mandate arrangement whereby payment for these services may be satisfied, at White Rock's election, via the issue of fully paid ordinary shares or cash or any combination of shares/cash. White Rock has elected for the payment of services provided in the April to June 2015 quarter to be made by an issue of shares for the total invoice amount. The issue price of the shares was calculated by using the Volume Weighted Average Price ('VWAP') over this period to determine the number of shares issued.

The offers of fully paid ordinary shares were made without a prospectus pursuant to Part 6D.2 of the Corporations Act 2001 (the "Act") and this notice is being given pursuant to section 708A(5)(e) of the Act. As at the date of this notice, White Rock has complied with its financial reporting and auditing obligations under Chapter 2M of the Corporations Act and its continuous disclosure obligations under section 674 of the Act. In particular, there is no information which White Rock has withheld from Listing Rule 3.1 disclosure under the confidentiality carve-out from disclosure.
