APPOINTMENT OF DIRECTOR

Commenting on Mr Hansen's appointment to the Senetas board, Chairman Francis Galbally said: "I am delighted that Dave has agreed to join our board. He adds an important range of skills to the company. Dave's initial focus will be to work closely with the team to help drive our international sales growth as well as our significant product development and innovation program.
