MANALTO SECURES SECOND SÓSHLR DISTRIBUTION PARTNER

 leading web hosts and service providers. Manalto also showcased Sóshlr as a key sponsor of the
 AppDirect Conference in San Francisco last week and is a sponsor of The Whir Hosting industry event
 in Washington DC in late-October.
- In addition to the Company's integration of Sóshlr into the Odin global APS hosting platform as a key planned third party distribution channel targeting Odin's estimated 10,000+ service providers, Manalto has commenced activity to further integrate Sóshlr into an additional cloud app market and platform provider, AppDirect, to enable growth of the Company's third party distribution channel, with plans to be fully integrated by the first quarter in 2016.
