#### **Board Renewal and Succession**

## Stephe Wilks to retire at the end of 2015

Stephe joined the Board of Total Communications Infrastructure Limited (TCI) in 2005 prior to its merger with Service Stream and has brought to the Board extensive telecommunications, legal and management skills. Stephe also served as the Board Chair in 2010, and the Board thanks him for his significant contribution.
