Response to query - Appendix 3Z for Mr Feng Sun

We refer to your email dated 9 November 2015 regarding the above matter.

1. Explanation why the director's notice was lodged late

We inadvertently failed to lodge that form with the ASX within the required time frame due to an administrative oversight. On 10 July 2015, the market was fully informed at all relevant times with respect to the date of resignation of Feng Sun as a director. But we recognise that the Appendix 3Z is still a required disclosure.

Company arrangements with directors to ensure that the Company is able to meet its disclosure under listing rule 3.19A

The Company has the following arrangement in place:

- (i) A security trading policy which governs directors dealing in securities. As required by the ASX Listing Rules, the Company notifies the ASX of any transaction conducted by directors in the securities of the Company within five days of the transaction taking place.
- (ii) A continuous disclosure policy to promote transparency and investor confidence and ensure that all interested parties have an equal opportunity to obtain information, which is issued by the Company. The Company is committed to complying with the continuous disclosure obligations contained in the listing rules of ASX and under the Australian Corporations Act, and ensuring that all shareholders and the market have an equal opportunity to obtain and review full and timely information about the Company's securities.
- (iii) The declaration of directors' interest generally is a standing agenda item for board meetings.

3. Additional steps the Company intends to take to ensure compliance with listing rule 3.19B

The Company considers that its current arrangements are adequate to ensure compliance with listing rule 3.19B. The Company's directors are aware of their disclosure obligations. While the late lodgement of the Final Director's Interest Notice is regrettable it is not indicative of the Company's approach to meeting its disclosure obligations, and the Company will strive to ensure that all future obligations are met timeously.
