## By E-lodgement

### **Issue of Shares to Lokku Vendors under the Lokku Acquisition Agreement**

Mitula Group Limited ("**Mitula**" or the "**Company**") (ASX:**MUA**) advises that a total of 3,777,677 new fully paid ordinary shares were issued today as detailed in the accompanying Appendix 3B.

On 8 May 2015, the Company completed the acquisition of 100% of the issued share capital of Lokku Limited pursuant to the terms of an acquisition agreement (**Lokku Acquisition Agreement**) between the Company and the former shareholders in Lokku Limited (**Lokku Vendors**).

The consideration payable by the Company to the Lokku Vendors included a deferred consideration component of up to €3 million based on the operating performance of Lokku Limited following Completion.

Under the Lokku Acquisition Agreement, the Lokku Vendors were granted the option to apply all or part of this deferred consideration amount towards the purchase of new ordinary shares in the capital of the Company at a subscription price of \$0.60 per share. Two of the Lokku Vendors have subsequently exercised this option to acquire 3,777,677 new fully paid ordinary shares for an aggregate subscription price of AU\$2,266,606.

All of the above shares will be subject to voluntary escrow arrangements until the day after the release of the Company's half year accounts for the 6 month period ending 30 June 2016.
