Enterprise Agreement with SpeedCast Executed

ZipTel Limited ("**ZipTel**" or "the **Company**", ASX: ZIP) is pleased to announce it has now signed a binding commercial agreement with SpeedCast to white label the Zipt application for an initial period of two years. - The commencement of the agreement will be upon delivery of the Zipt white label application at which time the full terms of the agreement will be released to ASX
