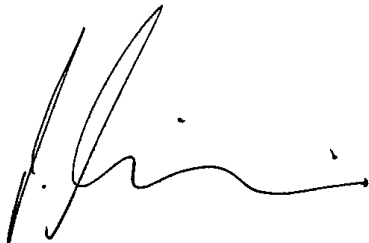
**NEW ISSUE OF SHARES

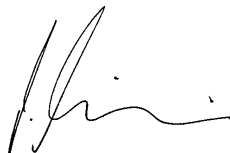
