

During the month to 31 January 2016 Glennon Small Companies Ltd delivered a gross portfolio return of -1.44%, while the S&P/ASX Small Ordinaries Accumulation Index fell 5.11%. Since inception Glennon Small Companies Ltd has delivered a 7.55% gross portfolio return while the S&P/ASX Small Ordinaries Accumulation Index has risen 5.50%. At the end of the month the portfolio held 38.6% cash.

Commentary

Glennon Small Companies completed its first six months of trading with a strong 7.55% absolute return and having outperformed the S&P/ASX Small Ordinaries by just over 2%. Over the past month cash weightings have been stable, closing the month at 38%.

Volatility has continued this year, with heavy losses in the S&P/ASX 200 leading this index into bear market territory (20% decline from recent highs) by early February. Meanwhile the Small Ordinaries has fared better, falling only 12%, and avoiding the significant decline of the major banks. Beyond the outperformance of small caps, the number of stocks listed on the ASX dwarfs the top 100 by a factor of more than 20 times; opportunities are significant for active investors.
