Under current Accounting Standards, the Company is required to provide for tax on any gains that may arise on such a theoretical disposal, after the utilisation of brought forward losses.

The February 2016 figures are after the payment of the interim dividend of 10 cents per share and the January 2016 figures are before the provision for the dividend.

These figures do not include the effects of any dilution that would arise from the conversion of the outstanding Convertible Notes.
