PLACEMENT AND APPENDIX 3B

Bluechiip Limited ("**Bluechiip**" or the "**Company**") (ASX:BCT) advises that 4,385,965 new fully paid ordinary shares were issued today without disclosure to investors under Part 6D.2 of the Corporations Act as detailed in the accompanying Appendix 3B.

The shares were issued in order to take up part of the shortfall arising under the Company's recent SPP and were issued at a price of \$0.0285 per share (\$125,000 in aggregate), being the issue price under the SPP.
