CLEANSING STATEMENT

Pilbara Minerals Limited (ASX: PLS – the "Company" or "Pilbara") has today issued and allotted 10,000,000 Ordinary shares to Valdrew Nominees Pty Ltd under shareholder approval obtained at the May 30 2014 General Meeting of Shareholders.

Below is the applicable Cleansing Notice.

Secondary Trading Exemption:
