AMENDED ASX APPENDIX 3B

On 7 May 2014, PHW Consolidated Limited (“Company”) issued a prospectus for the offer of 450 million Shares at an issue price of \$0.00325 per Share to raise \$1,462,500, together with 1 free attaching Option for every 3 Shares subscribed for and issued (“Prospectus”). The Prospectus was amended by the issue of a supplementary prospectus on 22 May 2014 and further amended by the issue of a supplementary prospectus on 19 June 2014.

The supplementary prospectus issued on 19 June 2014 provided for the issue up to an additional 75,000,000 Shares (and an attaching 1 for 3 Option) at an issue price of 0.325 cents per Share to raise up to an additional \$243,750 under the Prospectus.

The Company announced an ASX Appendix 3B on 7 May 2014 in relation to the Prospectus.

Attached is an amended ASX Appendix 3B in relation to the Prospectus which reflects the amendments pursuant to the supplementary prospectus issued on 19 June 2014.
