COMPLETION OF PLACEMENT

Black Range Minerals Limited (ASX: BLR) ("the Company") is pleased to advise that further to the announcement of 19 June 2014, it has now completed the placement of 333,333,334 ordinary shares ("Shares") at an issue price of \$0.0045 per Share to Siebels Hard Asset Fund Ltd ("Placement").

(a) The dilution to existing shareholders as a result of the Placement is as follows:

(b) The Company undertook the Placement pursuant to Listing Rule 7.1A as it was considered to be the most certain and efficient method for raising the required funds at the time. The Placement has also allowed the Company to secure a new institutional investor to its register. The Company also notes that as per the announcement of 19 June 2014, it will be undertaking a \$0.6 million underwritten share purchase plan following completion of the Placement, pursuant to which eligible shareholders will be entitled to apply to purchase up to \$15,000 of new Shares at the same issue price as the Placement.

(c) The Placement was not underwritten.

(d) The Company will incur ASX listing fees of approximately \$5,985 in connection with the Placement.

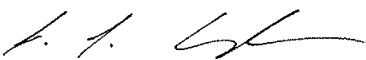
