Resources sector shows strength as Four Mile uranium mine opens

Premier Jay Weatherill today officially opened the first stage of the Four Mile Uranium Mine in the State's Far North, highlighting the continued importance of job creation through the State's minerals and energy resources sector.

Congratulating the Joint Venturers, Quasar Resources Pty Ltd and Alliance Craton Explorer Pty Ltd, Mr Weatherill said the high grade and scale of the Four Mile uranium deposit is of world-wide significance.

"This is one of the most substantial uranium discoveries anywhere in the world in the past 25 years," Mr Weatherill said.

"Following on from the successful mining method of the nearby Beverley and Beverley North deposits, the new Four Mile Mine represents another important chapter in continuing uranium mining in this world class region.

"The project has already involved a private sector investment of more than \$120 million and demonstrates the strength of the South Australian mineral resources and energy sector."

The initial stage of mining operations will collect information and assess mining conditions of the Four Mile East section of the deposit while the joint venturers make use of existing capabilities and minimise environmental disturbance by processing the resource at the nearby Beverley facilities.

Heathgate, an affiliate to Joint Venturer Quasar Resources, will provide services to the mine and operation of its nearby plant.

Heathgate employs 140 people and actively promotes employment opportunities to the Adnyamathanha people. Aboriginal employment in operational staff at the Beverly mine site has been greater than 20 per cent over the past decade. Traditional owners will receive native title payments as well as opportunities for employment with the mine.

The broader South Australian community will benefit from royalties, and through a boost in the procurement of goods and services locally and interstate.

Treasurer and Minister for Mineral Resources and Energy Tom Koutsantonis said our extensive resources, mining expertise and stewardship has enabled South Australia to be a world leader in the uranium industry.

"Our home-grown Plan for Accelerated Exploration (PACE) collaborative drilling initiative made a valuable contribution to the original discovery of the Four Mile deposit," Mr Koutsantonis said.

- A joint venture between Quasar Resources Pty Ltd and Alliance Craton Explorer Pty Ltd.
- First discovered April 2005
- Located 550km north east of Adelaide in the Frome Basin

- Mining lease approved by State and Federal regulators in April 2012
- More than \$120 million has been invested in the project so far
- Planned to produce up to 1.6 million pounds from Four Mile in 2014 from the multimillion pound deposit.
