### COO Sign on and Retention Bonus

Mr Philip Byrne was granted a Sign-on and Retention Bonus pursuant to the terms and conditions of his original Employment Contract with the Company.

The terms of the bonus are that the Company is required to issue 10,000,000 fully paid Ordinary Shares in six (6) equal tranches at six (6) month intervals commencing six (6) months after the commencement of his employment on 29 December 2011. The first five (5) tranches will be 1,666,667 Ordinary Shares with the final tranche being 1,666,665 Ordinary Shares. As at 30 June 2014, there were 1,666,665 rights to Ordinary Shares outstanding under the terms of the Sign-on and Retention Bonus.

In the event of termination of the Employment Contract by the Company (other than for cause in which case no further shares shall be issued) a maximum of 1,666,667 of any of the unvested shares shall be issued. In the event of termination by Mr Byrne, the Company is not obliged to issue any unvested shares.
