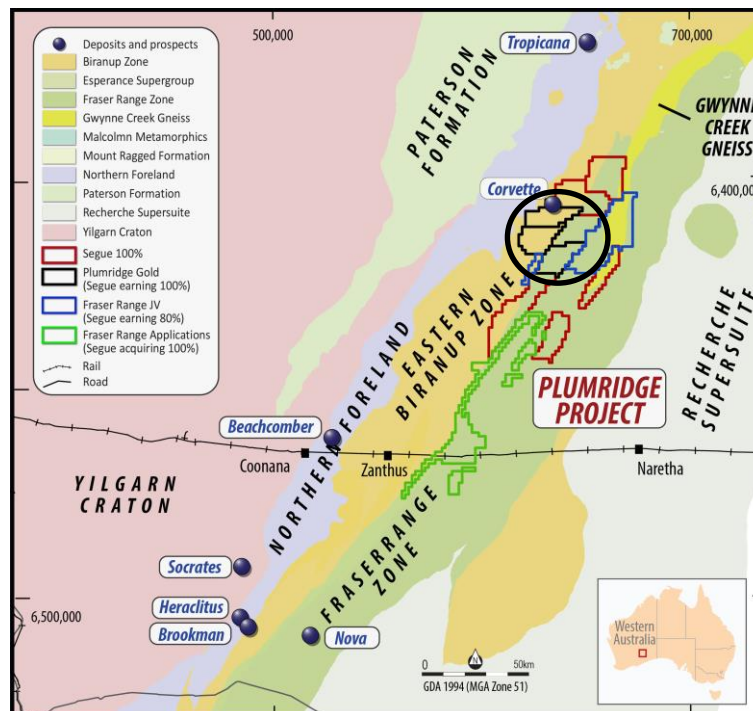

SEGUE COMPLETES PLUMRIDGE ACQUISITION

Segue Resources Limited (**Segue** or the **Company**) is pleased to announce that it has completed the acquisition of a 100% interest in four exploration tenements at the Plumridge Nickel and Gold Project in the Fraser Range Province of Western Australia from International Goldfields Limited (**IGS**). The four tenements total 832km² and are highly prospective for Nova-style nickel sulfide deposits and contain the Corvette gold prospect (**Figure 1**).

Segue initially acquired a 65% interest in the four tenements for \$100,000 in cash and the issue of 50 million Segue shares (refer ASX announcement 9 April 2014). Segue has now acquired the remaining 35% interest in the four tenements (increasing its stake to 100%) by the payment of \$200,000 and granting IGS a 1% net smelter royalty.

Commenting on the transaction, Segue's Managing Director, Mr Steven Michael, said:

The payment of \$200,000 to complete the acquisition of the four tenements from IGS demonstrates Segue's commitment and confidence in the Plumridge Nickel and Gold Project. Segue is the 2nd largest ASX-listed tenement holder in the exciting Fraser Range Province, with approximately 4,200km² of granted tenements and 740km² of exploration licence applications. Importantly, Segue owns a 100% interest in nearly all of its tenements.
