### **COMPLETION OF CONVERTIBLE NOTE ISSUE AND CONVERSIONS OF DEBT TO EQUITY**

As part of its ongoing regeneration and recapitalisation process Advance Energy Ltd ("The Company") is pleased to announce that it has now completed the note holder capital raising of \$1.1m as previously approved by shareholders on 11 June 2014.

The company has also now completed the conversions of all current and previous notes to equity as well as converting any other amounts owed previously in accordance with the approvals received in the shareholders meeting held on 11 June 2014.

This process will clean up the balance sheet of all residual and legacy obligations incurred prior to the recapitalisation plan. It will also provide the company with cash to progress its activities to the next phase and the ability to commence work on current projects and identification of new opportunities.

An Appendix 3B is attached taking into account the share issues concerned and confirming the new capital structure.
