## Tranche 2 of Pacific Road Investment Complete

ABM Resources NL ("ABM" or "the Company") announces that Pacific Road Resources Fund II ("Pacific Road Capital") and ABM have finalised the Tranche 2 investment as approved by shareholders at the general meeting held on 27 June 2014.

The Company issued today 21,515,188 shares at 36 cents per share to Pacific Road Capital, increasing the cash position by a further \$7,745,467.68.

### Notice under Section 708A

The Corporations Act 2001 ("the Act") restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A.
