## PLUTON RESOURCES LIMITED Replacement Prospectus

On 9 July 2014, Pluton Resources Limited (**Pluton** or the **Company**) (ASX: PLV) lodged with the Australian Securities and Investments Commission (**ASIC**) a prospectus for a non-renounceable entitlement issue of up to 8,001,291,042 shares at an issue price of \$0.01 per share on the basis of 9 new shares for every share held on the record date, with a minimum subscription of \$47,500,000 and to raise up to approximately \$80,012,910 before expenses (**Offer**).

The Company advises that following discussions with ASIC, it has made some relatively minor amendments to the prospectus, and has today lodged with ASIC a replacement prospectus in respect of the Offer (**Replacement Prospectus**). The terms of the Offer remain unchanged.

The original timetable for the Offer contemplated that the opening date and despatch of the prospectus would be yesterday. As a result of the lodgement of the Replacement Prospectus, the opening date and despatch of the prospectus to ASIC will now occur on Friday 25 July 2014. All other dates of the indicative Offer timetable remain unchanged. The indicative timetable is set out below:
