**RESULTS FOR QUARTER ENDED

On June 4, 2013 Eurogold Limited's ("Eurogold or the Company") securities were suspended from trading until such time as the Company has sufficient activities to warrant re-quotations.

The Company is continuing to search for suitable opportunities that could allow re-quotations and deliver value to Shareholders.

As at today's date the Company has a share portfolio valued at \$2.86 million.

Taking into account the debt to Allied Group, the Company has an unaudited current NAV of \$0.0117.

On 13 March 2014 Eurogold entered into a Third Variation of Loan Agreement with the Allied Group of Hong Kong, Eurogold's largest shareholder. The term of this original loan facility which is fully drawn to HK\$11,800,000 (A\$1.7 million) has been extended to 31 December 2015.

On 13 March 2014 Eurogold entered into a new Loan Agreement with the Allied Group with a total amount available for draw-down of HK\$3,920,000 (A\$0.6 million). The term of the loan is to 15 December 2015 with interest at 12% per annum. Eurogold has drawn down HK\$1,120,000 (A\$150,000) from this new facility. No funds have been drawn-down during the quarter.
