ASX Announcement 30 July 2014

Quarterly Activities Report: 30 June 2014

GB Energy (ASX: GBX) ("the Company") is pleased to provide the following summary of activities conducted in the June 2014 quarter.

SOUTH AUSTRALIA EXPLORATION LICENCES

During the quarter, GB Energy executed a Native Title Mining Agreement (NTMA) for Exploration with the Arabana Aboriginal Corporation RNTBC. The NTMA covers both GB Energy's Stuart Shelf Copper-Gold-Uranium project (EL 5231 and EL 5255) and Mount Denison Uranium project (EL 5302).

The Company was also formally granted EL 5391, known as Lake Blanche, a large holding within the Frome Uranium Province prospective for sandstone-hosted uranium in Cenozoic sediments.

On 10 June, GB Energy advised the market that geophysical field surveys, including high-resolution heli-borne magnetics and ground gravity, had commenced on our Stuart Shelf Copper-Gold-Uranium project.

SHAREHOLDER UPDATE

On 7 April, the Company released a major Shareholder Update regarding the Company's exploration program in South Australia (see GBX announcement of 7 April 2014).

CESSATION OF EXPLORATION IN SLOVAK REPUBLIC

On 4 April, the Company announced that it will cease exploration activities in the Slovak Republic following the downgrading of the prospectivity of our Slovak licence areas and the need to prioritise exploration expenditure. The Company commenced procedures to surrender the exploration licences and wind-up our Slovak-based subsidiary.
