General Meeting

In accordance with Listing Rule 3.13.2, the directors of Global Resources Corporation Limited (ASX: GRM) ("Global" or "the Company") advise the resolutions put to shareholders at the General Meeting held earlier today were carried.

The resolutions carried were: -

- 1. "That, for the purpose of Listing Rule 7.4, and for all other purposes, Shareholders ratify the allotment and issue of 11,833,334 Shares on the terms and conditions set out in the Explanatory Memorandum."
- 2. "That, for the purpose of Listing Rule 10.11, and for all other purposes, Shareholders approve the issue of 3,333,336 Shares to Mr Mark Savich, a Director, on the terms and conditions set out in the Explanatory Memorandum."
- 3. "That, for the purpose of Listing Rule 10.11, and for all other purposes, Shareholders approve the issue of 1,000,000 Shares to Mr Alec Pismiris, a Director, on the terms and conditions set out in the Explanatory Memorandum."
- 4. "That, for the purpose of Listing Rule 10.11, and for all other purposes, Shareholders approve the issue of 500,000 Shares to Mr Stephen Everett, a Director, on the terms and conditions set out in the Explanatory Memorandum."
- 5. "That, in accordance with Listing Rule 7.2, Exception 9, and for all other purposes, Shareholders approve the performance rights plan for employees (including Directors) of the Company known as the "GRM Performance Rights Plan 2014" and the grant of Performance Rights under the Plan on the terms and conditions set out in the Explanatory Memorandum."
- 6. "That, subject to the passage of Resolution 5, in accordance with Listing Rule 10.14 and Chapter 2E of the Corporations Act, and for all other purposes, Shareholders approve the issue of up to 1,500,000 Performance Rights to Mr Mark Savich under the GRM Performance Rights Plan 2014, for no consideration and on the terms and conditions set out in the Explanatory Memorandum."
- 7. "That, subject to the passage of Resolution 5, in accordance with Listing Rule 10.14 and Chapter 2E of the Corporations Act, and for all other purposes, Shareholders approve the issue of up to 750,000 Performance Rights to Mr Alec Pismiris under the GRM Performance Rights Plan 2014, for no consideration and on the terms and conditions set out in the Explanatory Memorandum."
- 8. "That, subject to the passage of Resolution 5, in accordance with Listing Rule 10.14 and Chapter 2E of the Corporations Act, and for all other purposes, Shareholders approve the issue of up to 750,000 Performance Rights to Mr Stephen Everett under the GRM Performance Rights Plan 2014, for no consideration and on the terms and conditions set out in the Explanatory Memorandum."
