224 Dugan Street Kalgoorlie, WA 6430 At the start of the June Quarter, the Board of KalNorth Gold Mines Limited ("KalNorth or the "Company", ASX: KGM) undertook a detailed review of the Company's operations and strategy in consultation with its key management team. The Board identified the following goals:

- Eliminate the company's current level of debt;
- Substantially reduce the company's overheads;
- Progress opportunities with third parties to develop its existing projects; and
- Secure the future direction of the Company by establishing an ongoing revenue stream.

Over the last three months the Board has identified a number of promising opportunities with third parties and is currently in the process of negotiating with those third parties. The Board feels confident they will be able to achieve their stated goals within the short term whilst ensuring its portfolio of tenements remains compliant with statutory obligations.

Quarterly Summary:

- Maintained reduced operating and overhead costs.
- Continued to progress plans to re—commence mining at Lindsays with Confidentiality Agreement signed with Curtin University of Technology to promote further collaboration on developing innovative engineering solutions to exploit the narrow flat dipping lode beneath the open pit.
- At Spargoville, joint venture operator Mithril Resources Limited evaluated three targets with reverse circulation drilling, and earnt its initial 20% interest in the project
- At Kurnalpi, the company maintains prospecting activity by a core group of prospectors, which yields a small income from gold nuggets, but more importantly maintains the statutory tenement expenditure compliance and provides valuable geological information.

OPERATIONS REPORT:

Lindsays Mine

The company continued to focus on the re commencement of mining at Lindsays with the signing of a Confidentiality Agreement with the Curtin University of Technology (CUT), where by the company will supply information for the parties to continue progressing discussions and formulating an MOU into developing research opportunities on innovative underground mining practices at the Lindsays mine site. This work will involve collaboration with Curtin University's Western Australia School of Mines (WASM) campus.

Outlook

The company will continue to progress the development of tribute mining at Lindsays with an aim to secure an agreement with a preferred party during the September quarter and to commence initial redevelopment activities such as permitting. To complement the underground development the company plans to update the resource model.

EXPLORATION REPORT:

Continuing on the previous quarter, the company maintained its exploration activities during the June 2014 quarter to minimize operating expense but also to ensure meeting statutory compliance with the Department of Mines and Petroleum tenement conditions. Work has been restricted to project reviews, reconnaissance, and inspection of prospecting activities but to ensure minimum tenement expenditure commitments are met. At Kurnalpi, six prospecting parties working under agreement with the company continue to maintain an active working presence on almost the entire Kurnalpi tenement portfolio. This activity, whilst yielding very small revenue to the company in gold nuggets does assist both in complimenting the company's project expenditure to maintain tenement commitment, but also and more importantly adding geological knowledge to the Kurnalpi project. Kurnalpi Mining centre is noted for its long history of gold won by prospectors over a wide area but as yet the source has not been discovered.

A prospecting party also under agreement with the company has recently commenced activity at Lindsays, adjacent to the suspended mining operation. Again this work will assist with meeting the statutory tenement conditions.

No new drilling or surface geochemical sampling activity was conducted during the quarter.

<u>Spargoville (Mithril Resources Ltd 20% and earning up to 80%)</u>

During the Quarter, Mithril Resources Limited (ASX:MTH) reported conducting a program of reverse circulation drilling and downhole geophysics at its West Kambalda Project, located 30 kilometres west of Kambalda.

Three targets (**Hendrix**, **Floyd**, and **Zeppelin**) were drill tested with downhole EM surveying also undertaken at Hendrix and Floyd.

The drilling confirmed and extended a near surface zone of nickel mineralisation at Hendrix, and identified a zone of weak copper – zinc anomalism in a sulphidic shale horizon at Floyd. No significant results were returned from the drilling targeting the surface gold mineralisation at Zeppelin.

The targets are subject to a Farm-in and Joint Venture with Mithril Resources Limited (ASX: MTH) where Mithril during the Quarter, has successfully earnt an initial 20% interest having completed expenditure of \$0.32M (Stage 1). The Company is currently in the process of transferring the 20% interest to Mithril. Mithril can earn an additional 60% interest by spending a further \$1.68M by no later than 17 May 2017 (total expenditure of \$2 million over 4 years for an 80% interest).

Outlook

The focus of exploration activity for the June 2014 Quarter by the company will be the continued ongoing reassessment of the four key project areas to determine tenements or areas of tenements that are considered less prospective that could be either divested or relinquished to reduce the compliance costs. The company will also continue to assist prospecting parties to maintain a presence working tenements at Kurnalpi and Lindsays.

CORPORATE REPORT:

Finance


The Board have progressed negotiations with third parties and considered a number of alternatives to improve the company's financial position. The Board aims to once again become an active gold explorer and miner in the short term. The company has a portfolio of gold projects with resources within close proximity to existing third party processing facilities and discussions have involved ways to realize value from some of these assets.

Total expenditure for the quarter amounted to \$321,000 of which \$113,000 was attributable to exploration and evaluation, compared to \$287,000 the previous quarter.

The company's principal debt to loan holders remains unchanged.

In addition the company has a \$1.1million final deferred payment due to be paid to Pioneer Resources Limited by 6 March 2015.

The cash balance at the end of the quarter was \$160,000.

About KalNorth Gold Mines Limited

KalNorth Gold Mines Limited (ASX Code: KGM) is a gold mining company based in Kalgoorlie, Western Australia (WA). The Company's core suite of tenements, all 100% owned, are located some 50 to 80km north-east of the world renowned gold mining town of Kalgoorlie, WA. They cover approx. 1,200km² of highly prospective land. There are currently four gold projects each with resources within the KGM holding: Mount Jewell, Lindsays, Kalpini and Kurnalpi (collectively the KalNorth Field). Spargoville, south of Kalgoorlie, is a JV project with Mithril Resources Limited.

KalNorth Gold Mines is working towards establishing four gold mines across the KalNorth Field. Initially, all will be open pit operations, but each also has future underground potential. Ultimate development of these mines is dependent on favourable economic conditions. KalNorth transitioned to gold producer in January 2013 when it brought the Lindsay's Project into production. KalNorth mined Lindsay's for 7 months before ceasing mining in August 2013. KalNorth is currently exploring opportunities to develop the Lindsay's as an Underground Mine focussing upon the Parrot Feathers lode beneath the Stage2 open pit.
