Navitas to open sixth US pathway program – signs agreement with Florida Atlantic University

Global education services provider Navitas Limited (ASX: NVT) has today announced the execution of a ten year agreement with Florida Atlantic University (FAU), to establish a University Programs pathway program for international students on the University's Boca Raton campus.

The pathway program, to be called Navitas at Florida Atlantic University, is scheduled to open in January 2015 and will offer undergraduate pathway and pre masters programs across a range of disciplines including accounting, arts and humanities, engineering, marketing and international business and trade. Students who successfully complete the Navitas pathway will be eligible to continue their studies in undergraduate and postgraduate courses at FAU.

FAU was opened by President Lyndon B. Johnson in 1964 and is part of Florida's State University System. FAU is a comprehensive public university that currently serves approximately 30,000 students at sites throughout its six-county service region in southeast Florida.

The University has a strong reputation as a teaching university and growing strengths in science related research fields, especially biomedicine, biotechnology, ocean engineering and coastline security. The university currently has approximately 600 international students.
