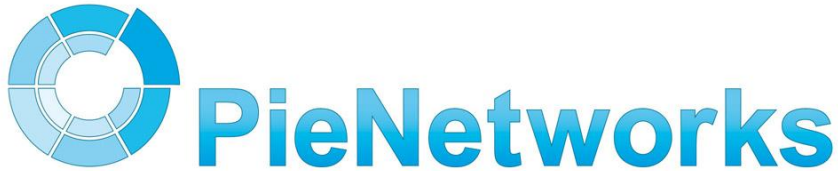

Notice under Section 708A(5)

We refer to the Appendix 3b released to ASX on 12 August 2014 concerning the placement of 75,000,000 ordinary shares at 4 cent per share. The placement is a condition precedent to the completion of an acquisition by the Company. Both the placement and the proposed acquisition received shareholder approval at a general meeting held on 11 August 2014.

The Company has today confirmed the issue of 75,000,000 fully paid ordinary shares on 12 August 2014.
