## **RETRACTION OF INVESTOR PRESENTATIONS on ASX dated 8 and 15 August 2014**

Statements implying the targets are viable require a greater reasonable basis, otherwise they are taken to be misleading to shareholders.

The information relating to future targeted readership growth and forecasts has been retracted as no reasonable grounds for making the forecasts were included in the announcements. The information regarding Participation in the Entitlement on page 9 of the 15 August 2014 Investor Presentation is incorrect.
