## NON-EXECUTIVE DIRECTOR APPOINTMENT

Segue Resources Limited (**Segue** or the **Company**) is pleased to announce the appointment of Dr Frazer Tabeart as a Non-Executive Director of the Company. Segue would also like to advise that Mr Matthew Foy has resigned from the Board and will remain Segue's Company Secretary.

Dr Tabeart is a geologist with 25 years' global exploration and resource development experience. After graduating from the Royal School of Mines, London with a degree and PhD in mining geology, he emigrated to Australia and spent 16 years with the Exploration Division of WMC Resources Limited (**WMC**).

Whilst with WMC Frazer spent six years living in Kalgoorlie exploring for nickel and gold in the Eastern Goldfields, followed by an extensive period in WMC's project generation team with a focus on global regional target identification and project generation for Ni-Cu and Cu-Au. This culminated in a two year period where he was regional manager for a large portfolio of Ni-Cu projects in Africa, with an emphasis on Botswana, Zambia, Tanzania, Namibia, Mozambique and Malawi.

In 2005 Frazer left WMC and joined the Mitchell River Group of companies, initially as Head of Exploration for Albidon Limited. In this role he was responsible for the management of a large portfolio of Ni-Cu-PGE projects across southern Africa covering over 60,000km<sup>2</sup> across four countries. This included a large project covering 17,000km<sup>2</sup> around the world-class Selebi-Phikwe nickel mine in Botswana which is hosted in deformed rocks of the Limpopo Mobile Belt, an ancient geological terrane very similar to the Albany-Fraser province.

Frazer is currently Managing Director of African Energy Resources Limited, an ASX listed power development and generation company, Director of Mitchell River Group (a private project generation and development company) and principal of Geogen Consulting Pty Ltd, a consultant to the minerals industry.

Commenting on the appointment of Dr Tabeart, Segue's Managing Director, Mr Steven Michael, said:

*I am delighted to welcome Frazer to the Board of Segue where his extensive nickel exploration experience will be pivotal in advancing and refining the Company's exploration strategy at the Plumridge Nickel Project.*

*The appointment of Frazer adds to Segue's high calibre exploration team along with Peter Langworthy (Omni GoeX) and Newexco.*

*I would also like to thank Matthew Foy for his contribution to the Board of Segue over the past year.*
