# Confirmation of Dispatch of Offer Documents and Entitlement and Acceptance Forms

Metals of Africa Limited ("Metals" or "the Company") (ASX: MTA) confirms that dispatch of the non-renounceable rights issue offer document, dated 3 September 2014, together with personalised Entitlement and Acceptance Forms was completed today, Tuesday 23 September 2014.
