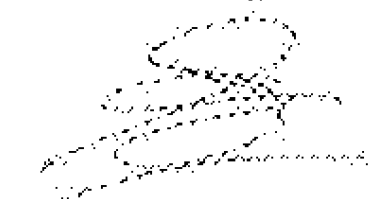

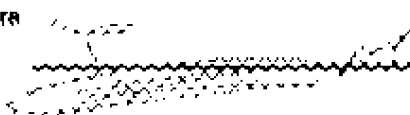

DIRECTIONS

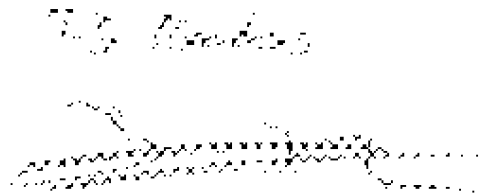

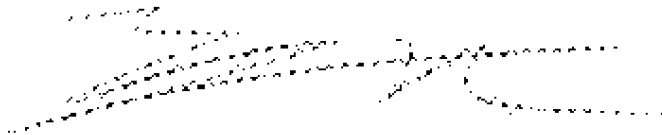
