- **REPAYMENT OF LOAN AGREEMENT**

Fox Resources Limited (ASX: FXR) (**Company**) advises the Company has fully repaid a Loan Agreement entered into with Murdoch Pty Ltd (**Agreement**) for a \$125,000 convertible loan to the Company (details of which were announced to ASX in the Non Renounceable Rights Issue Prospectus on 11 June 2014) on the 9 October 2014. In accordance with the Agreement, at the conclusion of the Entitlements Issue (refer ASX announcement 5 May 2014), the remaining balance of the loan will accrue interest of 8% per annum and 250,000 fully paid ordinary shares will be issued for each month the balance of the loan remains unpaid up to 30 September 2014.

In connection with this repayment, the Company has today agreed to issue the lender (who is not a related party of the Company) 750,000 fully paid ordinary shares in the Company at nil cost.

An Appendix 3B is attached. The Company advises this issue falls within the Company's existing placement capacity under ASX Listing Rule 7.1 and is not subject to Shareholder approval.


