CLEANSING STATEMENT

Stratos Resources Limited (ASX: SAT – the “Company” or “Stratos”) has today issued and allotted 21,200,000 shares under the Share Purchase Plan as announced 16 September 2014. Additionally, it has issued and allotted 6,000,000 shares via a private placement.

Below is the applicable Cleansing Notice.

Secondary Trading Exemption:
