FOX INCREASES ITS INTEREST IN THE MOUNT MARIE JOINT VENTURE

Fox Resources Ltd (ASX Code: FXR) ("Company") announces a change in the beneficial interest of the Mt Marie Joint Venture. Under the Joint Venture agreement both parties are required to contribute to maintain their interest. Expenditure since the management of the Joint Venture changed has resulted in a change in the beneficial interest of each party.

Fox Resources has increased its holding from 60% to 69.85%.

The Mt Marie Joint Venture covers exploration leases E47/1806 and E47/1807, located 15km South of Karratha, Western Australia. These tenements are prospective for nickel (and copper) deposits similar in setting to the previously exploited Radio Hill deposit and also host several known gold occurrences.

The company also confirms that it is in the negotiations with the Ngarluma Aboriginal Corporation over a variation to the existing heritage agreement that once signed will allow a heritage surveys to be conducted over the high priority Osborne EM Target located within the Mt Marie Joint Venture. This target is located at the base of a mafic intrusive body in a similar geological setting as the nearby Radio Hill and Sholl nickel (and copper) deposits.

Once the heritage surveys have been completed the company intends to progress the drill testing of this high priority target. It is hoped that this drill program could occur in late 2014 however the exact timeframe for the drilling is dependent on the heritage survey being completed prior to the upcoming Law and Cultural time for the traditional owners of the region.

More information is expected within four weeks.
