Perth based African focussed explorer Walkabout Resources Ltd (ASX:WKT) is pleased to report its activities in Botswana and Tanzania for the September 2014 quarter.

Takatokwane Coal, Botswana

The 7 billion tonne Takatokwane Coal Project is currently under Pre-Feasibility Study. During the quarter, the Company assessed the necessary scope variations brought about by up-scaling of the project to around 20 million tonnes per annum.

Consequently, the Company has been finalising the design, at a Scoping Study level, which will include the employment of Drag Line mining machines and Rope Excavators within the context of four strip mines. The geometry of the No. 2 coal seam at Takatokwane is ideal for large tonnage, long life mines similar to those being planned in the Galilee Basin in Australia.

The Botswana government have appointed Aurecon, an Australian rail consultant to be the lead study manager responsible for determining the development plan for the Trans Kalahari Railway development. A Company representative attended a Botswana Coal Railway workshop in which Aurecon and several dozen other stakeholders participated. Outcomes at this workshop included a schedule, put forward by Aurecon, which foresees the development of the TKR railway to be completed by 2020.

The Company applied for, and has subsequently been granted, a renewal to the JV licence PL 035/2007 which had completed its legal term of operation. The Minister of Mines, Energy and Water of Botswana, has renewed the licence following successful and satisfactory ongoing work by Walkabout and its JV partners.

Kigoma Copper, Tanzania

At the highly prospective Kigoma Copper Project, five areas have been targeted for ground geophysical surveys to provide drilling targets. During the quarter, budgets and project plans were sought from service providers. The cost will range between \$100,000 and \$150,000 for a survey of 4 or 5 of these areas. The Company needs to secure funding for these and this has been held over until the 2015 season.

The Directors have participated in several detailed negotiations regarding funding partners and cornerstone investors. The current investment climate is not conducive to striking commercial arrangements which enhance shareholder value.

The Executive Directors have not received any cash remuneration during the quarter.

Subsequent Events

The Company has signed an Option to Acquire, through a staged purchase, 70% of 4 highly prospective exploration licences for graphite contiguous to and between the known graphite licences of another explorer. The Option Agreement has been executed with a Tanzanian National Individual who is the 100% holder of the licences.

The licences are highly prospective, contain known outcrops of graphite and are in an area known for large and jumbo sized flakes and higher than average grades.
