MVPL did not make the IRA deposit or the half yearly interest payments. The majority of the holders of its senior secured notes have agreed to forbear MVPL's default for failure to deposit US\$5 million in the IRA and MVPL's failure to pay the half yearly interest payments until 14 November 2014.
