SECOND TRANCHE OF \$10 MILLION PLACEMENT COMPLETED

OTOC (**ASX:OTC**) (“OTOC” or “the Company”) is pleased to advise it has received \$2 million in funds and issued 10,000,000 in new shares at 20 cents per ordinary share as the second tranche (“Tranche 2 Placement”) of a \$10 million placement to professional and sophisticated investors, as announced to the ASX on 11 September 2014.

The Tranche 2 Placement was approved by Shareholders at the Company’s Annual General Meeting held on 3 November 2014. An Appendix 3B is appended to this announcement.

Net proceeds from the Placement will be used to fund future acquisitions in-line with OTOC’s national surveying strategy and for general corporate purposes.
