COMPLETION OF TRANCHE 1 OF PLACEMENT

Audalia Resources Limited (**Audalia**) (ASX: ACP) is pleased to announce the completion of Tranche 1 of the Placement as announced to ASX on 30 September 2014. Pursuant to Tranche 1, a total of 2,000,000 fully paid ordinary shares were issued to raise \$750,000. The issue of Tranche 1 Placement Shares is within the Company's 15% capacity under Listing Rule 7.1.

As previously announced, the funds raised from the overall \$1.5 million Placement will be used to repay the short-term loan of \$700,000 due for repayment on 20 January 2015, to advance the metallurgical testwork at the Medcalf Project, to progress the Company's ongoing exploration activities at its Medcalf and Gascoyne Projects and for general working capital.
