AssetOwl's inspector360 platform provides solution for rental inspections during Victorian lockdowns

Highlights:

- AssetOwl is providing its inspector360 platform to Victorian property managers, with the capability for remote routine real estate inspections and virtual tours for sales, allowing these essential functions to resume safely and efficiently
- Rollout in Victoria is part of a partnership between AssetOwl and the Real Estate Institute of Victoria (REIV), the peak membership body comprising more than 80% of real estate agencies in Victoria

Enterprise property management platform provider AssetOwl Limited (ASX: AO1, **Asset Owl** or **the Company**) is pleased to announce it has entered into a partnership with the Real Estate Institute of Victoria (REIV) to assist in providing Victorian real estate agents with remote routine inspection and virtual tour for sale capabilities through inspector360, the Company's revolutionary photo-centric property management platform. This software is designed to enable agents and managers to conduct professional and efficient remote inspections and virtual tours during and after the state's COVID-19 restrictions.

Remote routine inspections with inspector360 are contactless, convenient and cost effective. To carry these out, a property manager simply schedules an inspection, contacts and sends a link to the tenant, uses inspector360 to start a one-way video/two-way voice call, controls the inspection taking photos remotely when required, completes the report and sends to the landlord. To the Company's knowledge, this is the only product available on-market today which allows property managers to seamlessly direct inspections remotely through a video call whilst also being able to capture high resolution photos and review them in real time.

AssetOwl Chairman, Simon Trevisan, said:

"We are delighted to partner with the REIV and excited by the untapped growth potential that the Institute can unlock for AssetOwl.

"We developed and launched inspector360 to enable true remote real estate management prior to the COVID-19 pandemic. The impact of COVID-19 then prompted us to develop remote routine inspections as an add-on to inspector360.
