Completion of \$596,000 Placement

Pursuit Minerals Limited (ASX:PUR) ("Pursuit" or the "Company") is pleased to announce that it has completed the placement of 66,222,222 fully paid ordinary shares (**Placement Shares**) to the clients of CPS Capital (**Placement**).

The Placement Shares were issued with an issue price of \$0.009 per Placement Share, raising \$596,000 (before costs). The Company issued the Placement Shares out of its 7.1 placement capacity.

CPS Capital will be paid a cash fee equal to 6% of the amount raised under the Placement.

Further details relating to the issue of the Placement Shares are set out in the Appendix 3B that the Company released on 15 October 2020 and the annexed Appendix A.
