WA's Sandstone gold project surpasses 730,000oz with new resources for three deposits

- A maiden Mineral Resource for Sandstone's new McIntyre satellite open pit deposit, and updated estimates for the existing Twin Shafts and Goat Farm deposits, collectively add a further 40,100oz of gold.
- The new contributions take Sandstone's total current inventory to 732,000oz.
- More than 91% of McIntyre and 84% of Twin Shafts' estimates are classified in the higher confidence Indicated category, while Goat Farm has been classified as an Inferred Mineral Resource, with rig access constraints precluding a higher drill density.
- McIntyre represents the third of five new satellite open pit deposits quantified by Middle Island's 50,000m drilling campaign in 2020.
- All three deposits will now be optimised to determine the in-pit Mineral Resources likely to contribute to Ore Reserves in Sandstone's current feasibility study.
- Drilling results and maiden resource estimates for the new Ridge and McClaren satellites, will be compiled for release shortly, now that the assay laboratory backlog has been cleared.




SANDSTONE GOLD PROJECT (WA)

Introduction

Explorer and near-term gold developer, Middle Island Resources Limited (Middle Island, MDI or the Company) is pleased to advise that a maiden Mineral Resource estimate has been prepared for its McIntyre satellite open pit gold deposit, along with updated open pit estimates for the existing Twin Shafts and Goat Farm deposits. The updates take Sandstone's Mineral Resources to a new level of 732,000 ounces. The estimates follow completion of the Phase 2 infill and extension drilling program, representing part of the 50,000m 2020 exploration and resource definition drilling campaign at the Company's wholly-owned Sandstone gold project in the central goldfields of Western Australia. The drilling was exclusively focussed on the definition of additional open pit Mineral Resources prior to their inclusion for assessment as Ore Reserves in the 2020 feasibility study (FS).

The location of the various deposits (including McIntyre, Twin Shafts and Goat Farm) and prospects assessed under the 2020 drilling campaign are shown in Figure 1 below.





Mineral Resource Estimates

A summary of the maiden Mineral Resource estimate (MRE) for the McIntyre gold deposit, along with updated MRE for the Twin Shafts and Goat Farm deposits, were independently prepared for Middle Island by Mr Shaun Searle of Ashmore Advisory Pty Ltd and are provided in Table 1 below.

The Mineral Resources have been compiled under the supervision of Mr. Shaun Searle who is a director of Ashmore Advisory Pty Ltd and a Registered Member of the Australian Institute of Geoscientists (MAIG). All Mineral Resources figures reported in the table above represent estimates at October 2020. Mineral Resource estimates are not precise calculations, being dependent on the interpretation of limited information on the location, shape and continuity of the occurrence and on the available sampling results. The totals contained in the above table have been rounded to reflect the relative uncertainty of the estimate. Rounding may cause some computational discrepancies.

Mineral Resources are reported in accordance with the Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves (The Joint Ore Reserves Committee Code – JORC 2012 Edition).



Geology and Geological Interpretation

The Sandstone Gold Project occurs within the Sandstone Greenstone Belt (SSGB). This is a triangular belt of geology interpreted as a north-plunging anti-form located at the northern end of the Southern Cross province, which forms the central spine of the Archaean Yilgarn craton. The SSGB consists of mafic volcanic and intrusive rocks with subordinate ultramafic, banded iron formation (BIF) and siliciclastic sediments. Granitoid plutons intrude the southern margin of the belt. The metamorphic grade is greenschist facies, although amphibolite facies assemblages are locally developed along the flanks of the belt.

At Twin Shafts and Goat Farm, gold mineralisation occurs in shear/breccia zones hosted within greenschist facies mafic rocks with meso-thermal quartz veining and associated silica-carbonate-chlorite-pyrite alteration. At McIntyre, gold mineralisation is mainly hosted within BIF units, generally occurring at or proximal to oblique faulting, with some peripheral gold mineralisation occurring in the mafic country rock. The majority of identified mineralisation occurs in weathered zones with some overlying laterite mineralisation.

Sampling and Sub-sampling Techniques

For earlier drilling completed by Herald Resources and Troy Resources, RC samples were passed directly from the in-line cyclone through a rig mounted multi-tier riffle splitter. Samples were collected in 1m intervals into bulk plastic bags and 1m calico splits (which were retained for later use). From the bulk sample, a 5m composite sample was collected using a split PVC scoop and then submitted to the laboratory for analysis. The 1m calico splits were submitted to the laboratory if the composite sample returned assay values equal to or greater than 0.2g/t Au. In certain cases, selected samples from some holes were passed from the cyclone through a rig mounted multi-tier riffle splitter, and samples collected into calico bags at 1m intervals were submitted directly for analysis. The remaining bulk sample was placed on the ground in 1m intervals.

For MDI Phase 1 RC drilling, sampling was undertaken by collecting 2-3kg of RC chips off the drill rig's cone splitter; the 1m samples were then composited to 4m interval samples with a two-tier riffle splitter, but intervals of expected mineralisation were sampled at 1m intervals. Where 4m composites returned assays greater than 0.2g/t Au, the 1m bulk samples were split down to 2-3kg sub-samples using a two-tier riffle splitter and submitted for analysis.

For MDI Phase 2 RC drilling, sampling was undertaken by collecting 2-3kg of RC chips off the drill rig's cone splitter, with 1m samples sent direct for assay.

For MDI diamond drilling, HQ3 core was sampled as quarter core, cut using a diamond core saw and sampled at 1m intervals or to geological contacts. The core samples were always collected from the same side of core for consistency.

Drilling Techniques

The estimates are based on good quality reverse circulation (RC) and diamond (DD) drilling data. The drill hole spacing is predominantly 20m by 20m across the breadth of the known mineralisation at McIntyre and Twin Shafts, increasing to a maximum 40m x 40m spacing at Goat Farm. RC drilling was conducted with a 140mm face sampling hammer and oxide DD drilling was conducted from surface with HQ core diameter barrel and a triple tube.



Classification Criteria

The Twin Shafts and McIntyre Mineral Resources are classified as Indicated and Inferred Mineral Resources based on data quality, sample spacing and lode continuity. The Indicated Mineral Resource is defined within areas of close spaced RC and DD drilling of less than 20m by 20m, and where the continuity and predictability of the lode positions is good. The Inferred Mineral Resource is assigned to areas where the drill hole spacing exceeds 20m by 20m, where small isolated pods of mineralisation occur outside the main mineralised zones and to geologically complex zones. Goat Farm is classified as an Inferred Mineral Resource.

The extrapolation of the lodes along strike has been limited to a distance equal to half the previous section drill spacing or to 20m. Extrapolation of lodes down-dip has been limited to a distance equal to the previous down-dip drill spacing or to 40m. Areas of extrapolation have been classified as Inferred Mineral Resource or were not classified.

Sample Analysis Method

For Herald and Troy drilling, assays were conducted by SGS Australia Pty Ltd in Perth WA using 50g charge fire assay with an AAS finish.

For MDI drilling, assays were variously undertaken by Intertek, Nagrom and SGS in Perth WA using a 50g charge fire assay with ICP-OES finish.

Estimation Methodology

The block models were created and estimated in Surpac using Ordinary Kriging (OK) grade interpolation. The mineralisation was constrained by wireframes prepared using a nominal 0.3g/t Au cut-off grade with a minimum down-hole length of 3m.

Samples were composited to 1m based on an analysis of sample lengths inside the wireframes. After statistical analysis of individual lodes, it was determined that high grade cuts ranging between 10g/t and 30g/t Au were warranted for some domains, resulting in 19 composites being cut at Goat Farm, one composite being cut at McIntyre and one composite being cut at Twin Shafts.

The block dimensions used in the models were 5m EW by 10m NS by 5m vertical with sub-cells of 1.25m by 1.25m. These dimensions were selected based on Kriging Neighbourhood Analysis. The McIntyre block model was rotated on a bearing of 305° to match the approximate strike of the mineralisation. At Goat Farm, bulk densities ranging between 1.9t/m³ and 2.7t/m³ were assigned in the block model dependent on lithology and weathering. At Twin Shafts, bulk densities ranging between 1.86t/m³ and 2.7t/m³ were assigned in the block model dependent on lithology and weathering. At McIntyre, bulk densities ranging between 1.8t/m³ and 3.2t/m³ were assigned in the block model dependent on lithology and weathering. These densities were applied based on average bulk density measurements obtained from HQ3 diamond core drilled at the respective deposits.

In addition, high grade limits were utilised in the interpolation macro to ensure that high gold grades were restricted to a set maximum search radius.



Cut-off Grades

The reported Mineral Resources have been constrained by the mineralisation solids and reported above a cut-off grade of 0.5g/t Au. The cut-off grade was estimated based on parameters derived from the Sandstone gold project Pre-Feasibility Study completed in 2016.

The Twin Shafts deposit is situated approximately 500m west of the Sandstone mill, the Goat Farm deposit is situated approximately 750m northwest of the Sandstone mill, whilst the McIntyre deposit is situated approximately 2.8km east-northeast of the Sandstone mill. All are located within granted Mining Leases.

Additional geological, geotechnical, engineering and metallurgical studies are in progress to further characterise gold mineralisation and establish the viability of mining the McIntyre, Twin Shafts and Goat Farm deposits, which are anticipated to make a meaningful contribution towards the current Sandstone Feasibility Study.

Mining and Metallurgical Methods and Parameters

Previous pit optimisations suggest that the Plum Pudding and Old Town Well deposits can be mined via open pit techniques.

Metallurgical testing is currently being conducted at each deposit with results pending. MDI anticipates that similar overall gold recoveries will be similar to the nearby Goat Farm, Twin Shafts and Shillington deposits at 93%, for which previous production records are available.

Comments by Managing Director, Mr Rick Yeates:

"The maiden Mineral Resource for the McIntyre satellite deposit, and updated Mineral Resources comprising the Twin Shafts and Goat Farm open pit deposits increase the total Sandstone project Mineral Resources to 732,000oz gold. The McIntyre and Twin Shafts deposits will now be optimised and mine designs prepared to determine Ore Reserves likely to contribute to the FS.

"The lower strip ratio anticipated at the McIntyre satellite deposit suggests it may be scheduled for mining and processing earlier in the mine life, making a very valuable contribution to the project. Mining of the Twin Shafts southern extension will provide for greater tailings capacity within the existing in-pit licenced storage facility, while a cut-back of the existing Goat Farm open pit will provide for a larger capacity in-pit tailings storage option, beyond the initial open pit production scenario, should it be required.

"Final resource definition samples for the Ridge and McClaren deposits have now been received from the assay laboratory. We look forward to compiling and announcing these results shortly, prior to finalising Mineral Resource estimates for these two remaining satellite deposits."

In addition to the Mineral Resources reported above, the residual portion of the Two Mile Hill tonalite deeps Exploration Target, lying between 500m and 700m below surface, is not included and remains to be re-quantified as an Exploration Target or, with further drilling, a Mineral Resource.

The Company also notes that maiden Mineral Resource estimates for the Ridge and McClaren deposits are imminent.

There are no Ore Reserves currently reported in relation to the Sandstone gold project.

In all cases, Mineral Resources are estimated and reported in accordance with the 2012 Edition of the 'Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves' (the JORC Code).
