REQUEST FOR VOLUNTARY SUSPENSION

On 20 October 2020, Roto-Gro International Limited (ASX: RGI) (RGI) lodged an announcement with the ASX regarding a \$1.9m technology purchase order (Order) from Canniberia LDA (Portugal) (Canniberia). Subsequent to that announcement, RGI entered into a trading halt to assist it to manage its continuous disclosure obligations in relation to the Order.

Having regards to the above, ASX has requested further information from RGI regarding the Order, relating in particular to the conditions precedent to the Order and the Canniberia pre-license approval process. RGI intends to respond to those questions at the earliest opportunity to ensure that the market is fully informed, however it is unlikely to be able to provide a full response to ASX's queries prior to the end of the current trading halt. As such, RGI now seeks a voluntary suspension in its securities effective immediately in relation to the above.

In accordance with Listing Rule 17.2, RGI advises that:

- (a) the voluntary suspension is sought to assist RGI to manage its continuous disclosure obligations and provide substantive responses to ASX's queries in relation to the Order, to ASX's satisfaction, such responses which rely on information being provided from certain third parties;
- (b) it expects the voluntary suspension to last until the earlier of a further announcement being released in relation to the Order or the commencement of normal trading on 26 October 2020; and
- (c) it is not aware of any reason why the voluntary suspension should not be granted.
