European Metals Holdings Limited ("**European Metals**" or "**the Company**") (ASX & AIM: EMH, FSE: E861.F) advises that it has completed the issue of 723,323 CDIs in respect to the third draw down of the Fund Facility Agreement between 6466 Investments Pty Ltd and European Metals. 300,000 CDIs have been issued under Listing Rule 7.1 and 423,323 CDIs have been issued under Listing Rule 7.1A.

The Company also advises that it has issued 2,500,000 options, exercise price of \$0.42 per option expiring on 23 October 2023 and 1,000,000 options, exercise price of \$0.45 per option expiring on 23 October 2023 to various consultants under the terms and conditions of the respective investor relation agreements.
