

CLEANSING NOTICE & APPENDIX 2A

Esports Mogul Limited ("the Company") advises that it has issued 500,00,000 Tranche 1 Placement Shares as set out in the Company's Appendix 3B dated 14 October 2020 as well as 750,000 fully paid ordinary shares under the Company's Employee Incentive Plan. An Appendix 2A is attached.

As announced 14 October 2020, the Company secured firm commitments from new and existing institutional and sophisticated investors to raise A\$8 million through the issue of 800 million New Shares at an issue price of A\$0.01 per New Share. New Shares issued under the Placement include one free attaching listed option ('Option') for every two New Shares issued, exercisable at A\$0.02 on or before 31 October 2022. The Options and Tranche 2 Placement Shares are subject to shareholder approval at the Company's General Meeting anticipated to be held in late November. A prospectus will be issued by the Company when the listed options are issued.

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act), the Company gives notice that:

- (a) the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
