## Option Exercise Raises \$250,000 Cleansing Statement & Appendix 2A

Ardiden Limited (ABN 82 110 884 252) (ASX: ADV) (**Company**) advises that it has today issued 12,500,000 fully paid ordinary shares (Shares) pursuant to the exercise of 12,500,000 Unlisted Options with a \$0.02 exercise price and 31 December 2021 expiry date.
