

Quarterly Activity Report for the Period Ending 30 September 2020

Talon Petroleum Limited (ASX: TPD) ("**Talon**" or "**Company**") is pleased to present its September 2020 quarterly report.

1. **Walyering Farm-in**

During the quarter, the Company executed formal documentation with Strike Energy Limited (Strike) in respect to a farm-in agreement over EP447, located in the onshore Perth Basin, Western Australia.

Under the terms of the farm-in, Talon will acquire a non-operated 45% interest in EP447, which contains the Walyering wet gas prospect, as well as a right of first refusal over an entry into the EP495 block to the north, which contains the analogous Ocean Hill gas discovery.

As consideration for the acquisition of interest in EP447, Talon must contribute A\$6 million towards the cost of an appraisal well on the Walyering Prospect. The Company has paid a \$1 million transaction bond to Strike that will be applied to its free-carry obligations.

The Walyering well, which is expected to cost A\$9 million to drill, will be added to Strike's planned 2021 multi-well Perth Basin campaign. Strike has completed its design and identified a proposed location. Subsequent to the end of the quarter, Strike secured the Ensign Rig 970 for the drilling of the Walyering appraisal well. This is a very strong outcome for the JV and Talon shareholders given the intense competition for rigs in WA at the moment.

Walyering holds a gross 86Bcf of gas and 2.18mmbbls of liquids (best estimate in-place prospective resource)¹. Ocean Hill, which is currently held 100% by Strike, has a gross 2C Contingent Resource of 360Bcf (gas) and 1.18mmbbls (condensate).

The estimated quantities of petroleum that may potentially be recovered by the application of future development projects relate to undiscovered accumulations. These estimates have both an associated risk of discovery and a risk of development. Further appraisal and evaluation is required to determine the existence of a significant quantity of potentially moveable hydrocarbons.

Talon confirms that it is not aware of any new information or data that materially affects the information included in that announcement and that all the material assumptions and technical parameters underpinning the estimates contained in that announcement have not materially changed and continue to apply

Newly acquired and interpreted 3D seismic over EP447 has allowed Strike to apply its Perth Basin technical expertise to Walyering and reconcile past technical challenges with the prospect.

Walyering's proximity to infrastructure and low CO₂, and high liquids components will assist with a reduction in development and production costs and commercial viability in the event of success.

At the end of the quarter, completion of the farm-in remained subject to the receipt of standard regulatory approvals, which was expected in due course. Upon approval, Strike and Talon will form an unincorporated Joint Venture in EP447.

2. Completion of A\$5 million capital raising

To provide funding for its proposed farm-in with Strike and to progress its UK North Sea exploration portfolio, Talon successfully completed a share placement to institutional and sophisticated investors to raise A\$5 million in July.

The placement was undertaken at an issue price of \$0.002 per share. New shares were issued alongside a free attaching option on a 1-for-2 basis, and with an exercise price of \$0.004 expiring on 28 February 2022.

A shareholder meeting held in September saw the passing of resolutions to approve the issue of Tranche 2 securities under the placement, the participation of directors David Casey and Peter Stickland in the placement and the issue of the attaching options among other resolutions.

3. Corporate

Subsequent to quarter end Mr Peter Stickland and Mr Graham Doré resigned from the Board to pursue other business interests. The Board welcomed Mr Douglas Jendry.

Mr Jendry has had a distinguished career in the resources sector having worked as a geologist and, over the last 25 years, in various consulting, advisor and director roles with ASX and AIM listed companies. He has broad experience in all aspects of the oil and gas industry has had significant dealings over the years with brokers, investment bankers and various government authorities alike.

4. UK offshore licensing round

As part of the UK's 32nd Offshore Licensing Round, Talon submitted a number of bids for Licence Areas identified as having strong exploration potential and that could be acquired with low cost work program requirements.

In September, the Company was notified by the UK Oil and Gas Authority (OGA) that it had been offered three Licence Areas for which it submitted bids. Formal award letters for these Licence Areas are expected to be received in the near future, with Talon to assess each in the context of its broader UK North Sea portfolio.

Through the Licensing Round, the OGA awarded 113 licences to 65 different companies, demonstrating strong interest and appetite for oil and gas exploration in the UK North Sea.

5. UK North Sea farm-out process

Talon remains committed to its UK North Sea exploration portfolio and is continuing with its farm-out efforts on the Skymoos, Rocket and Vantage prospects. Despite the challenging macro-economic environment due to the COVID-19 pandemic, the level of engagement and interest remains strong, with several new parties entering the data room during the quarter. However, the timing of any successful farmout remains uncertain.

Talon recently secured a one-year work phase extension to its Skymoos Licence, providing with certainty around tenure for all four of highly prospective licences, which is critical to delivering the best possible outcome in farm-out negotiations.

Also boding well for the process has been the recent recovery and stability in the Brent Crude oil price to around US\$40/bbl, which is generally above the break-even point for UK North Sea oil projects. With this development, there has been a return of M&A and other activity to the region.
