### **Quarterly Report for the Period Ended 30 September 2020**

Nex Metals Explorations Ltd (Nex or the Company) provides the following update on recent Company activities.

The Company has been working with Metalicity Limited (ASX: MCT) during the quarter on their drilling and exploration campaign at the Leipold, McTavish, Champion and Cosmopolitan projects under the farm-in agreement dated 6 May 2019 (see ASX announcement of the same date). ### **Re-Commencement of Tailings Trial**

During the quarter the Company reactivated the trial processing of 2 X 10,000 with equipment being sourced and personnel appointed. Majority of equipment has arrived on site subsequent to quarters end. Various processes are being trialed on the tailings to ensure continuity to the larger balance of tailings, which approval application documentation has been started via environmental consultants. Application is expected to be submitted to the DMIRS next quarter.

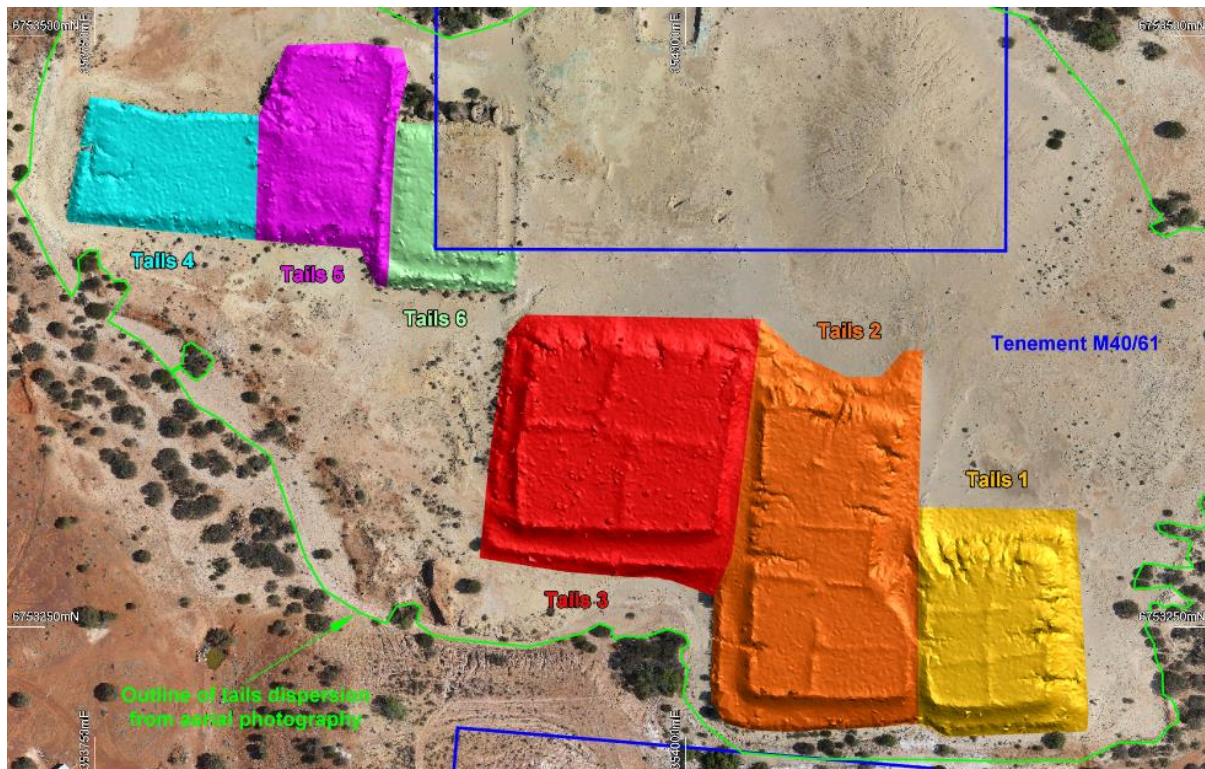
In late October 2017 Nex Metals drilled a total of 81 aircore holes for 497 metres over the tailings stockpiles (Figure 1). There are six distinct tail stockpiles located on Cosmopolitan tenement M40/61. Drilling was designed to test the full depth profile of these stock piles which were up to seven metres high. Drilling confirmed the grades previously identified by the Nex Metals soil sampling program. The overall average grade of the Cosmopolitan tails is 0.69 g/t Au. However, examination of the individual tails stockpiles indicate that certain stockpiles are higher grade than others. This is shown in Table 1, with stockpile 5 showing a mean grade of 1.33g/t Au.

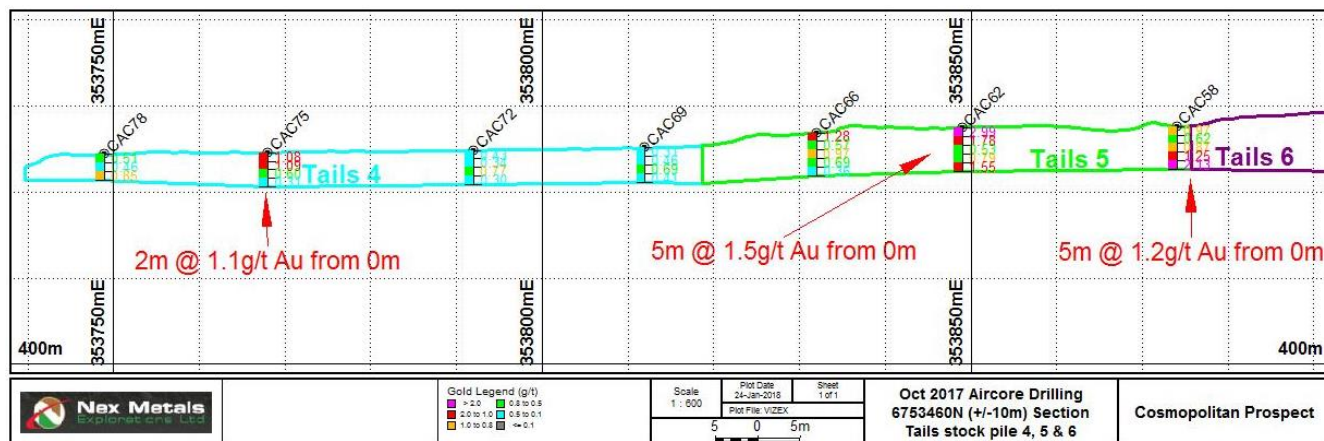


Figure 2. 6753430N Cross section (+/-10) showing aircore drilling across Cosmopolitan stockpiles 4, 5 & 6.

Figures 2 shows representative cross sections through stockpiles 4, 5 and 6.
