

Vesting of Performance Rights

3 November 2020

HSC Technology Group Ltd (ASX: HSC) (Company) wishes to advise that 35,000,000 Performance Rights granted to Graham Russell have vested in accordance with their terms. Please refer to attached Appendix 2A seeking quotation of the Ordinary Shares that have issued on the vesting of the Performance Rights.

On 3 December 2019 the Company announced its transaction with Essence APAC which included appointing Graham Russell its Managing Director.

Upon entering into an Executive Services Agreement with Graham the Company agreed to issue to him or his nominee a number of Performance Rights. These were issued as part of his remuneration package in order to provide a performance linked incentive component to motivate and reward his performance.

Of the Performance Rights that have vested, 25,000,000 of these were linked to a vesting condition of \$2,000,000 of revenue being received by the Company during the period from the issue date and 31 December 2020. The grant of these were approved by Shareholders at the Company's general meeting held 17 January 2020.

The remaining 10,000,000 Performance Rights were allocated and approved by Shareholders at the Annual General Meeting held 15 June 2020. These rights were awarded as part of an incentive package designed to link his performance and align his interests with that of Shareholders to the work to improve the share price of the Company's securities.

The vesting of those 10,000,000 Performance Rights was linked to the Company's shares remaining at least \$0.01 calculated upon the 20-day volume weighted average price. This vesting condition has now been satisfied.

Given the Company's financial position at the time of his appointment as Managing Director the Board decided that a robust incentive scheme for Graham designed to align the interests of Shareholders and management was advantageous to both. Through Graham agreeing to accept a relatively modest base cash salary, this allowed the Company to conserve cash.

The Board congratulates Mr Russell on reaching achieving these milestones which is an acknowledgement of some of the success that has been achieved since his appointment.
