PERSOLKELLY agrees new 3 year contract with JXT

PERSOLKELLY is a global leader in the staffing industry and recruitment market. The new contract is significant for Nvoi as it demonstrates that there is demand for the JXT product and it validates Nvoi's ability to serve its target market, which includes global staffing agencies. As a stand-alone contract, Nvoi does not consider the fees are material in the context of its overall operations and the strong pipeline of major new and renewing contracts on the short-term horizon.

Mr Butler said, "This contract is another great success for Nvoi as we continue to build our global business. Product development work on a simplified platform continues and we remain on track to bring this to market ahead of schedule."
